

2019-20 access and participation plan monitoring

Provider impact report

This impact report summarises the progress made by NCG against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

1. Ambition and strategy

NCG's ambition and strategy as detailed in the 2019-20 access and participation plan:

In the Access and Participation Plan, NCG's strategic priorities set against Access, Success and Progression of students from underrepresented groups were:

• We aimed to improve access for students from specific underrepresented groups across three of our Colleges. Students who disclose a disability or difficulty at Newcastle College University Centre (NCUC), students from BAME heritage at Kidderminster College and at West Lancashire College access for students from all underrepresented groupings.

• We also had strategic ambitions to improve continuation rates for all students from underrepresented groups, with a particular focus on improving continuation for white British males from low participation backgrounds.

• We aimed to improve award rates for white British males from low participation backgrounds and also students from BAME heritage.
